 - ii. 214 Huisache Hill Woods BP 2019-005 & DP 2019-004: Mr. Woods for 214 Huisache Hill has submitted all documents needed for BP 2019-005 and DP 2019-004 permits, approval pending Inspection fee for BP 2019-005 and application fee for DP 2019-004.
 - **iii.** Others: 3980 Youngsford Rd Garza: Mr. Garza wants to add to his existing garage, no application has been received at this time.

- **ii. Wetz Road:** Garry Montgomery from Utility Engineering Group presented to the City Council "Wetz Road Drainage and Roadway analysis". No action taken at this time.
- **iii. Mechanic concrete**: Utility Engineering Group, reviewed the mechanical concrete road construction technology that has been discussed at Council in the past. In their opinion this technique has a few challenges and some benefits. Discussion only no action taken.
