## 4. Public Hearing – Budget Hearing for FY 2021

The City of Santa Clara City Council will hold a public hearing during the regular meeting on Monday, August 24, 2020 at 6:30 p.m. The meeting will be held at the City Hall, 1653 N Santa Clara Rd, Santa Clara, Texas, to listen to public comments concerning the budget FY 2021. The budget is available for review on the city's web site or at the City Hall, Mon – Thru 9:00 am – 2:00 pm. This budget will raise more total property taxes than last year's budget by \$3,785 @ 4.3%, and of that amount \$2,681 is tax revenue to be raised from new property added to the tax roll this year. The tax rate is the same as last year.
