Ordinance No. <u>2022 - 002</u>

AN ORDINANCE OF THE CITY OF SANTA CLARA, TEXAS, AMENDING SECTION 18. OF ORDINANCE 2020 – 005 "CITY FEE SCHEDULE" TO ADOPT AND ESTABLISH CITY FEES FOR TOWING SERVICES; REPLACING AND REPEALING ALL OTHER FEE SCHEDULES AND PARTS OF ORDINANCES IN CONFLICT; PROVIDING FOR PENALTY, SEVERABILITY, OPEN MEETINGS AND EFFECTIVE DATE CLAUSES.

Whereas, the City of Santa Clara continues to experience significant growth and development;

Whereas, the City Council of the City of Santa Clara acknowledges that the continued benefit of keeping adopted fees charged by the City located in one ordinance;

Whereas, the City Council acknowledges the benefits to the City that fees and charges be adopted and amended to adequately to cover the City's actual cost of providing certain services;

Whereas, the City Council of the City of Santa Clara finds that it is in the best interest of the City and its residents for request for service or use of City resources to bear the cost of expenditures to fulfill such request or use;

Whereas, the City Council of the City of Santa Clara desires to adopt and establish City Fees for towing services;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SANTA CLARA, TEXAS, THAT;

A. Section 18 of Ordinance 2020 - 005 is hereby amended to read as follows:

Section 18. Miscellaneous Fees.

The following fees and charges are established and shall be collected for Special Events, Park Rental, Film Projects, and other miscellaneous activities or services as listed:

B. Repeal of Conflicting Ordinances and Parts of Ordinances.

All ordinances or parts of ordinances in conflict with this Ordinance are hereby repealed to the extent of such conflict.

C. Severability.

If any provision of this Ordinance or the application of any provision to any person or circumstance is held invalid, the invalidity shall not affect other provisions or applications hereof which can be given effect without the invalid provision or application, and to this end the provisions of this Ordinance are declared to be severable.

D. Effective Date.

This Ordinance shall take effect immediately from and after its passage and publication in the manner set forth with the provisions of the Tex. Loc. Gov't Code.

E. Savings Clause.

This Ordinance shall remain in full force and effect, save and except as amended or repealed.

F. Open Meetings Act.

It is hereby found and determined that the meeting at which this Ordinance is passed was open to the public as required and the specific notice of the time, place and purpose of said meeting was given as required by the Texas Open Meetings Act, Chap. 551, Tex. Gov't Code.
