NOTICE IS HEREBY GIVEN THAT THE CITY COUNCIL OF THE CITY OF SANTA CLARA, TEXAS WILL HOLD A REGULAR CITY COUNCIL MEETING ON THE DATE, AND AT THE TIME AND LOCATION AS NOTICED ABOVE REGARDING THE TOPICS CONTAINED HEREIN.

C. PUBLIC COMMENT

Interested persons wishing to provide public comments at this meeting must submit a complete public comment request form to the City Secretary for each topic they wish to speak about no later than five (5) minutes **PRIOR** to the start of the meeting. All public comment speakers will be allowed to speak for three (3) minutes on each topic for which they properly submitted a public comment request form.

Public comments on agenda items will be taken after the topic is introduced and after any scheduled presentation and staff recommendation is provided.

At this time, public comments will be taken from the audience on any topic NOT listed on the agenda. **No discussion or formal action will be taken at this meeting on topics not on the agenda.** Inquiries about matters not listed on the agenda shall be directed to City Staff following the meeting.
