Councilmember Marian Carty made the motion to select the Cyber Liability and Data Breach Response Coverage through TML at \$1250.00, with City of Santa Clara's Municipal Court paying half of the fees of \$625.00. Councilmember John Reagan seconded the motion. Motion carried with 4 yes and 1 no (Atkins).

## 6. FY 2023-2024 Power Plant Contribution Funds for Youth Organization – authorization of disbursement for funds:

Councilmember John Reagan made the motion to fund \$500 to Santa Clara 4-H Club, \$750 to Marion Community Library, \$1500 to Boys State and \$500 to Itschner Pony Club. Councilmember Marian Carty seconded the motion. Motion carried.

## 7. Removal of City Marshal from Administrative Leave and Reinstatement to active duty:
