#### C. PUBLIC COMMENT:

All attendees and speakers are hereby reminded of the City's Decorum and Public Comment Policy.

Interested persons wishing to provide public comments at this meeting must be submit a complete public comment request form to the City Secretary or Assistant for each topic they wish to speak about no later the five (5) minutes **PRIOR** to the start of the meeting. All public comment speakers will be allowed to speak for three (3) minutes on each topic for which they properly submitted a public comment request form.

# Public comments on agenda items will be taken after the topic is introduced and after any scheduled presentation and staff recommendation is provided.

At this time, public comments will be taken from the audience on any topic NOT listed on the agenda. *No discussion or formal action will be taken at this meeting on topics not on the agenda.* Inquiries about matters not listed on the agenda shall be directed to City Staff following the meeting.

## D. PUBLIC HEARING(S)

Public hearings are for public information and input ONLY. No formal action will be taken at this meeting on the items discussed under this heading unless such action is otherwise listed on this agenda as an action item. The hearing(s) will be opened to receive and introduction/report/information from City Staff, then the applicant (if applicable) will be given an opportunity to speak, and then any other interested person(s) will be given an opportunity to provide comment on the hearing topic.

#### E. CONSENT AGENDA

The following routine, clerical, and administerial items require no public hearing and are anticipated to require little or no individualized discussion by the P & Z Commission. It is intended that these items will be acted upon with a single motion as a collective, singular item. Action, if any, will be taken in open session.
